BDE '75 CHRONOLOGY

PREFACE:

- Early in August 1974 the Department of the Army outlined actions to be taken in order to increase the combat capability in Europe while at the same time reducing the non-combat overhead in accordance with the provisions of the Nunn Amendment to the 1975 Military Authorization Bill. Based on input from both FORSCOM and USAREUR, DA issued planning guidance which in essence was the basi€ guidance for Bde '75. Refinement to this guidance, necessitated by both DA, FORSCOM and USAREUR capabilities resulted in the following requirements:
 - *The 2d Armored Division will deploy a Mech-Heavy Brigade from Ft Hood to FRG during the 3d and 4th Quarter FY 75.
 - *Deployment of the Mech-Heavy Brigade will be on a combined PCS and TDY basis. The Brigade HO of 114 spaces and the Support Battalion of 550 spaces will PCS all other elements (2 Inf Bns; 1 Armor Bn; 1 FA Bn; 1 Cav Trp (+) and 1 Eng Co (+) consisting of 3232 spaces will deploy TDY for 179 days.
 - *PCS elements will deploy at REDCON C1 for personnel (minimum of 95%).
 - *TDY elements will deploy at 100% of TO&E.
 - *Brigade will be equipped from pre-positioned stocks in the FRG.
 - *The Brigade will be temporarily stationed at MTA's in the FRG (Grafenwohr, Hohenfelds, Wildflecken).
 - *Dependents of PCS elements will not accompany sponsors and will not be authorized in the FRG until a permanent site is established and quarters are available.
 - *TDY elements will redeploy every 179 days and be replaced by a like unit.
 - *PCS personnel must meet deployability criteria as outlined in AR 614-30; TDY personnel will meet deployability criteria as determined by DA.
 - *Dependents remaining in the Fort Hood area will be supported by a formal Personnel Affairs Agency.
 - *Reconstitution of like deploying elements will be authorized.
 - *A dynamic education program will be conducted in the FRG by all elements of the deploying Brigade.

*Mechanized battalions will be configured as anti-tank heavy. (With TOW).

*This increased combat capability in Europe will be accompanied by a reduction of approximately 3800 support spaces in USAREUR.

The chronological sequence of actions to accomplish the personnel consideration of the above requirements is contained in this volume.







BRIGADE '75 CHRONOLOGY

The Department of the Army decision to deploy a "mech" heavy brigade of 3782 personnel from the 2d Armored Division to USAREUR by 30 June 1975 to increase the combat capability in Europe and to conform to the provisions of the 1975 Military Authorization Bill (Nunn Amendment) evolved from detailed planning coordination and implementation at all levels of command. A summary of these activities is as follows:

10 Aug 1974

Department of the Army message outlines reductions in Europe to be used to increase combat capability in compliance with the Military Authorization Bill (Nunn Amendment) and the Secretary of Defense Program Decision Memorandum. (PDM)

14 Aug 1974

DA requests USAREUR and FORSCOM comments to 10 Aug message.

19 Aug 1974

USAREUR comments submitted to DA. Comments provided USAREUR Alternative to reduce Non-Divisional Support Spaces.

20 Aug 1974

FORSCOM comments on 14 Aug request submitted to DA. Comments provided FORSCOM alternatives to increase combat capability in Europe with FORSCOM elements. Alternative included additional Bde in Europe from 2+10 Units. (Initial Bde '75 Concept).

26 Aug 74

Based on both USAREUR and FORSCOM imput to 10 & 14 Aug DA messages, DA issued planning consideration for providing an increased combat capability in Europe. (Acronym-ICCE). Considerations enumerated were:

*Bde '75 (ICCE) is compatible with the 16 Division force concept.

*Units selected to increase combat capability in Europe should have adequate manpower. (This appears to imply one unit).

*POMCUS stocks will be used to provide required equipment in Europe.

*A Brigade from the 2d Armored Division will be transferred to Europe.

21 Sep 1974

*The Brigade from 2d Armored Division will include a support package of 500 spaces.

28 Aug 1974 FORSCOM requests III Corps comments, reference DA message.

4 Sep 1974 GEIII Corps provides input to FORSCOM on meeting DA planning considerations enumerated in 26 Aug message. ITI Corps comments included following assumptions:

*Bde Mix-2 Tk, 1 Mech, 1 Arty, Cav Troops, Eng Co, MP Plt, Commo Plt, and Combat Spt Bn (not to exceed 500). Total package not to exceed 3500.

*Bde will deploy in 4th Quarter FY 75.

*Two Tk Bns and 1 Mech Bn will be reconstituted.

*Entire Bde will PCS.

*\$2 Million in UOC funds will be provided by 30 Nov 75.

*Approval and DA decision is required NLT 1 Jan 75.

III Corps also requested DA assistance in an increased pipeline. In addition, III Corps recommended a meeting be held with FORSCOM, III Corps and 2d Armd Div at an early date. III Corps would be ready to brief concept by 16 Sep 74.

16 Sep 1974 FORSCOM forwarded III Corps and 2d Armd Div concept to DA as required by 26 Aug message.

DA message provided most feasible course of action for increasing combat capability in Europe during FY 75. Guidance provided the following:

*Bde '75 elements from the 2d Armd Div will be deployed to Europe.

*Bde '75 Mix: 2 Tk Bns, 1 Mech Bn, 1 FA Bn, Cav Trp, Eng Co, HHC Bde and Div Spt Element, 550 spaces, total spaces-3501.

*USAREUR will reduce non-divisional support structure by 6568.

*POMCUS stocks will be utilized to equip deploying elements.

*Initial move will be a unit TDY move without dependents for at least the combat elements of the brigade. HIGHLY PROBABLE THAT UNIT ROTATION WILL BE DIRECTED IN FINAL DECISION.

*Units will deploy at a minimum of 95% strength.

Message further announced a policy conference at DA on 9-10-11 Oct (Later changed to 10-11-12 Oct).

26 Sep 1974 FORSCOM planning conference in Atlanta with III Corps and 2d Armored Division. Topic, Bde '75 Coordination Meeting.

28 Sep 1974 As result of 26 Sep meeting, FORSCOM message of 28 Sep requested III Corps outline plan NLT 7 Oct (Prior to DA meeting on 10 Oct). Guidance from FORSCOM includes:

*Bde of 2d Armored Division will deploy to Europe as follows:

-Bde HHC & Spt Bn-PCS (90 days after DA decision).
-Tk Bn; FA Bn, Cav Trp, Eng Co-TDY NLT 15 Apr.
(Latter Cav & Eng deployed with PCS units).
-Mech Bn-TDY 15 May.
-Tk Bn-TDY 15 Jun.

-IK BH-IDI IS JUH.

*All combat units will rotate in 179 days.

*2d Iteration deploys PCS less Mech Inf Bn which will continue rotation every 179 days.

*Bde Elements will deploy at $\underline{REDCON 1}$.

*Dependents authorized to remain in Government quarters.

*Funds will be provided. Message also requested III Corps/2d AD deployment criteria.

2 Oct 1974 DA message announces meeting at DA on 9-12 Oct.

9 Oct 1974

III Corps and 2d Armored Division concept for Bde '75 (based on FORSCOM guidance of 28 Sep) presented to FORSCOM prior to meeting with DA on 10 Oct.

10 Oct 1974

FORSCOM, III Corps, 2d Armored Division, USAREUR and DA for meeting on Bde '75 to finalize concept and resolve, and identify for further resolution, problem areas. Areas requiring resolution include:

*Brigade Mix, i.e. 2 Tk or 2 Mech.

*Magnitude of unit rotation, (i.e.) | Bn or all combat elements.

*Reconstitution-FY 75? or FY 76?

*Permanent stationing (Weisbaden?).

*UOC funds.

*Early public announcement.

*Use of Reforger Stocks (2+10 plus Reforger?)

(In Army staff briefing for CSA unresolved areas were brought out. In addition, 2 recommendations were made: 1-Entire 2d Arm Div fenced from 1 Nov 74 to 1 Mar 75. From that period on, only the rotational combat units be fenced. 2-Tank Team Replacement program at Fort Hood for the M60Al crews be discontinued on 1 Jan 75.)

14 Oct 1974

FORSCOM requests III Corps comments on 1st Cav providing units for Bde '75. (First indication on using 2 divisions for Bde '75).

17 Oct 1974

III Corps informs FORSCOM of its objection to Mech Heavy Bde Mix and the use of the 1st Cav in Bde $^{\prime}75$.

21 Oct 1974

Cdrs FORSCOM and USAREUR met in Heidelberg, Germany to discuss Bde '75. Following decisions were reached:

*Bde '75 will be mech heavy.

*Deployment will commence o/a 1 Mar 75 and be complete by 30 Jun 75.

*All deploying units will be at 100% fill (later modified by DA).

*All units less Bde HHC and Spt Bn will rotate.

*Tk and FA Bns will be at ALO-1.

*Bde will be stationed at Grafenwohr, Hohenfels and Wildflecken.

*Weisbaden is first choice for permanent location (Grafenwohr, Hohenfels and Wildflecken-2d).

*Period between rotations will be 18 month minimum.

3 Nov 1974

III Corps informed FORSCOM that the 2d Armd Div only participate in Bde '75, that reconstitution be in FY 75 and the rotation cycle be 12 months not 18 months.

5 Nov 1974

DA Decisions on Bde '75.

*A Bde of 2d Armd Div will deploy to Europe beginning o/a 1 Mar 75.

*Bde consists of: RM HHC-114 Spaces Spt Bn-550 Spaces Tk Bn-552 Spaces Inf Bn-852 Spaces (Approx.) Inf Bn-852 Spaces (Approx.) FA Bn-541 Spaces Spaces (Approx.) Cav Trp-161 Eng Co-157 Spaces (Approx.) TOTAL-3779 Spaces (Approx.)

V Corps informed 2d Armored Division of EW assignment policy - (i.e.) CINCUSAREUR has directed that EW will not be assigned to TO&E Inf, Arty, ADA (except Nike & Herc) Armor & Eng Bns, ACR HHT and Squadrons and Air Cav Trps. All other units OK as long as they are CAT II Units.

12 Nov 1974

Bde '75 News Release was prepositioned at Fort Hood for release at later date (Actual release, 12 Dec 74).

13 Nov 1974

DA announces deployability criteria for Bde '75.

13 Nov 1974

 ${\sf DA}$ announces personnel information for Bde '75. Message covered:

*Branch Clearance required for officers going PCS or $\overline{\text{TDY}}$.

*Grade Substitution-Enlisted - 2 Grades. Officers - 1 Grade lower.

*WAC's - Confined to CAT II units.

*Fence - Fence all 2d AD EM from CAP III Cycle K-2 to 1 Mar 75 and only EM of rotational combat units after 1 Mar 75.

*Stabilization - Stabilize EM of rotational units for 180 days in CONUS after completion of TDY.

*Strength - Units to deploy at sufficient strength to maintain personnel readiness of no lower than C-2 during TDY period. No replacements to units after 120 days.

20-23 Nov 1974
